

## The Great Triangle Treasure Hunt Triangle Credit Union Contest or Sweepstakes Official Rules

1. This contest runs from August 1, 2019 through August 31, 2019.
2. You must be Triangle Credit Union Kids Club or Teen Club member to redeem your savings deposit prize.
3. **DO NOT REMOVE THE TREASURE CHEST FROM ITS LOCATION**—after a picture is taken with it, please place it in its exact location so others can play.
4. All ten (10) treasure chests are located outside. No digging is required as all chests are above ground.
5. Please refrain from treasure hunting after 8pm Eastern Standard Time (EST).
6. Kids Club Members - Email pictures of member with the found treasure chest to [kidsclub@trianglecu.org](mailto:kidsclub@trianglecu.org) with a general description of where it is located. After photo submission (and verification of account), Triangle will deposit a \$5 reward into your Kids Club Savings Account. Only one \$5 reward deposit per Kids Club member.
7. Teen Club Members - Email pictures of member with the found treasure chest to [teenclub@trianglecu.org](mailto:teenclub@trianglecu.org) with a general description of where it is located. After photo submission (and verification of account), Triangle will deposit a \$5 reward into your Teen Club Savings Account. Only one \$5 reward deposit per Teen Club member.
8. Ten (10) members can earn an extra \$10 deposit by finding and retrieving a gold coin from the treasure chest. There is only one (1) gold coin per chest. When found, they bring the coin into your local branch to earn the \$10 (one gold coin redemption per member).

10. Contest is limited to the first 100 reward deposits.
